Audra welcomed the group and everyone introduced themselves.

- Marion – Vita training is going on. Taxes done for free for those earning less than household income of \$47,000 per year. She'll let us know when they start and will send out flyers.

Guest Presenter:

Nancy Martin – Dental Coordinator, Mid-Kansas Community Action Program –There is stimulus money to pay up to \$400 for an adult to receive dental service. This program is geared to help people who are underemployed or unemployed and looking for work. The voucher would require that the user pay a copayment of \$1 - \$20 and would be used only at identified dentists in Butler County and Wichita. They are not to be used for routine care, but can be used for extractions, fillings, etc. in order to aid the person to get back to work, or get back to looking for work. The user cannot have any other dental insurance. Nancy is looking to begin a dental coalition to help solve the need of dental care issues in Butler County. - During the presentation, Angie Baur of the Foundation of Greater Butler County noted that private donors in the Remington School District have set up an account with the foundation to help with dental issues in that school district.
- Marion noted that the United Way of El Dorado gave money for emergency dental care for adults with an El Dorado zip code.

Butler Dads – Mark Wirth:

Watch D.O.G.S. (Dads of Great Students) is a program from National Center for Fathering. The concept is to provide positive influence by fathers in schools. The minimum commitment is to serve all day, one day per year and during that time monitor entrances, lunchroom, and hallways, work in class, and be around the children. Schools where the program has run have seen less bullying and less violence. Mark has talked with the Ministerial Alliance about trying to initiate Watch D.O.G.S. in August 2010 for El Dorado Elementary Schools. Visioneering Update

All task force partners are welcome to attend Visioneering Birth – K Alliance. Because most cannot, three individuals were appointed to represent Butler County when the alliance began: Sue Barrientos, Debbie Mai, and Audra Kenneson. At the last Visioneering meeting, they discussed allowing only one person from an agency vote. Because there are several programs at

the Visioneering table that are funded through Rainbows, not all of the programs will have a vote – this includes the Debbie and Audra. Should Sue Barrientos not be at a Visioneering meeting, Butler County would not have a vote at the Visioneering table. At the last Visioneering meeting, Audra asked, “If 9 people from Butler County attended Visioneering meeting, would they have a vote if they came from 9 different agencies?” The answer she received was, “yes.”

Audra asked the task force what they would like to do. Several options were discussed.

- The group can think about it and make a decision next time about a course of action.
- The group can invite the co-chairs of the B-K Alliance to attend our next task force meeting and then ask them about the decision and present our concerns.
- The group can compose a letter to the co-chairs and the MSA council

The group decided to ask Sue Barrientos, the Chair of our task force, to compose a letter stating our concerns, asking that if there is a vote to be made at the B-K alliance, if she is not present to please delay the vote so we can notify our group and send representative(s) who can vote, to allow Audra or Debbie to have a vote for the community, or to be able to do proxy votes (members of our community sign their votes over to one representative). The groups asked that in the meantime, Debbie take our concerns and recommendations to the MSA Council.

A paper was sent around for signatures to attach to the letter created by Sue, and when the letter is created (prior to sending to the B-K Alliance co-chairs) Audra will send to the task force for them to see.
