Introductions & Announcements:

- Kris – brought new brochure: “Do you know the questions to ask?” for people who are looking for quality child care. Also: reminder that the name change from KACCRRRA to Child Care Aware of Kansas ®. (Kris, please note Audra learned how to do the registration mark just for you!) Kris was asked if the local R&R sites will be changing their names. Each R&R can determine their name. When asked specifically about Child Start, we were reminded that Child Start has many programs under the name of Child Start and the R&R is one of them. - Audra – Our next CPR/Pediatric First Aid class for Butler County child care providers will be in Rose Hill on April 9.

Guest Presenters:

Janett Jacobs – Tri-County CASA, Inc.: Tri County CASA, Inc. covers the 13th Judicial District (Butler, Greenwood, and Elk Counties). They are celebrating their 10th anniversary this year. They are a not-for-profit and depend on grants, donations, fundraising, and volunteerism to sustain their program. CASA started in Seattle, WA in 1977. The CASA's focus is "what is the best interest of the child." The CASA volunteer has three main functions: (1) serve as fact finder for the judge; (2) speak for the child in the court room, representing the child's best interest; and (3) continue to act as a watchdog for the child during the life of the case, ensuring that it is brought to a swift, appropriate conclusion (from pamphlet). Most of the cases are children who are in the system because of abuse/neglect. Volunteers must be at least 21 years old and submit written application. A background check (state and national) is conducted and once accepted, the volunteer completes 30 hours of training. Anyone can ask for a CASA to be appointed to a case (Guardian ad Litem, parents' attorney, social worker, family); the CASA is appointed by a Judge to the case. The CASA serves as an extension of the judge. In 2010 they served 84 cases, in 2009 they served 92. Volunteers can come from any walk of life. Luann McFadden – Rainbows United, Inc. Bright Beginnings: Luann is the Family Service Coordinator at Bright Beginnings. Rainbows is the lead agency of Infant/Toddler services in Sedgwick and Butler Counties. There are 37 networks in Kansas. They are often called "Part C," "tiny-k," and "Infant Toddler Networks." They serve children birth – three who have a delay or a disability of some kind. Some have a diagnosis before receiving services, others do not. They serve, on average, 100 children per year. They serve children in the 9 school districts of Butler County. Referrals come from hospitals, physicians, families, neighbors, foster care agencies, CASA, health department, child care providers, and other agencies. Children are served in their natural environment using a coaching method. One professional is assigned to the child by a team and that professional meets weekly with the team of professionals at Bright Beginnings. An IFSP (Individual Family Service Plan) is completed; it is flexible and family-based. Services are to the family, not just the child. When the child turns 3, a transition into the early childhood preschool program is completed; some children (about 25%) do not qualify for those further services. Smart Start/ECBG

Applications for scholarships and supplements are coming in and being filled quickly. We had a 9% cut for ECBG and we believe we may have a Smart Start cut in our future; though we do not know for sure. The first Incredible Years class began in January. We had our first CPR/First Aid training for the year and will have our next in Rose Hill in April.

Strategic Plan Work:

Audra handed out an advocacy packet, the first page of it connects us to the advocacy website created by Connecting Point (www.connectingpt.org). Also passed around was a list of 48 active

partners that Audra has begun. Please look the list over the list and help Audra by suggestion other names that we may want to add. Audra will look it over for spelling, make sure all notations are correct and contact each agency to ensure they want included in the partnership advocacy card we will create. We will NOT wait until the card is complete to do our advocacy – we must take action now. Cuts to programs and services are being reported. Kris noted “It is important to ACT.” Write letters, send emails, make phone calls, etc. If you are making a trip to Topeka and would like support from partners (emails, etc) please contact Audra and she will forward your information. We continue to advocate with one voice for the children of Butler County.
