Jennifer Stayner – The Arc of Butler County: The Arc of Butler County advocates for people who have developmental disabilities. They have many activities for young people in various locations around the county. Activities include: Butler Blazers (the team that participates in Special Olympics), a Tennis Program, Circle of Friends (with the Special Education Cooperative), and various meetings and trainings for parents and guardians of young people who have developmental disabilities. An activity they have had in the past, and are waiting to see if they have funding for this year, is Friday Fun Nights in Andover. Head Start Grant – Child Start – Jim Garrett

Child Start currently serves as the provider of Head Start in Sedgwick County and Early Head Start in Harper County. They have been in Sedgwick County since the mid 1970s. They have experience and success with their Head Start program. They believe adding Butler County and Greenwood County into their service area would be a good fit. There are two other agencies writing for Butler (and the other 5 counties currently being served by CDI). Child Start met with Sue Barrientos and Audra Kenneson about the possibility of writing for our county and then, two weeks ago, came to Butler County for a meeting to hear the community’s concerns and share information. They expect that the award for the new provider will be mid-school year. If Child Start is the agency awarded this area, they will keep things in place through the remainder of the school year and wait to make major changes (if there are changes) for the following school year. They plan to keep money in the community and hire from within the community when possible. Employees currently with Head Start in Butler County will be favored over new ones, if all qualifications are present. Thank you to those who have submitted a letter of support. Outcome of Community Survey of Smart Start Programs/Services - Audra

Audra passed around the report from the survey. We had 92 people respond. What we learned is that the community likes all of our services and wants us to work to keep all of our services.

Smart Start Early Childhood Block Grants – Audra & Kandi

We have learned that the Smart Start and Early Childhood Block Grants will be released in two different RFPs, and they will be released within the next week. The grants will not be competitive; they will be released only to those programs who have had the grants in the past. This is good news for Butler County. We will have a site visit in Wichita from the chair of the Kansas Children's Cabinet. Audra will be the representative for Butler County at that meeting on Monday, September 26 at 2:30 pm.

Other:

Susan H. – The State Interagency Coordinating Council meets monthly. They are impressed with the partnerships in Butler County and have asked to have their October meeting in Butler. Sue Barrientos helped to secure the room at BCC. The meeting will be on October 23 from 1:00 to 4:30 pm.
