- Kathy Gann – Agency name change to: "Children's Mercy Family Health Partners – a Coventry Company." Big changes coming to Medicaid. Healthwave will serve older population as well and members will see no changes in benefits and phone numbers. A new contract will be done and several out of state providers have put in for it. The governor's proposal will include three managed care providers. We know that the two who currently do it (Children's Mercy and UniCare) have put in along with other companies. The new proposal is that no one provider will have over 50% of the market share. The current contract will run through 12/31/12, so no changes right now.
- Nijah Fudge – Last night the All American City meeting went well. 63 families came and people ate. There were breakout sessions and a video was shown. The next step is a community meeting/Jamboree. - Kris Nicholson – A decrease in staff at Child Care Aware of Kansas which resulted in a reorganization. Kris is now the Quality Initiative Manager and oversees TEACH, WAGE\$, KQRIS Coaching and overseeing the grants. Child Care Aware of Kansas no longer will offer the BELIEF Institute.
- Jamie Downs – Changes in the Kansas register. Going through training in February and March and MUST have all changes begun by May. They are doing the surveys electronically. The public portal is coming. The next two weeks at the Health Department, they will be laying new carpet and tile!

**Bright Beginnings Semi-Annual Update – Susan Harsh**

Susan continues to need community-wide numbers of screenings done on children Birth – 3 years of age. If you do any screenings (mental health, hearing, vision, etc) if you turn the number in to Susan she can send it in on our community-based report. With the numbers turned in to her for the 2011 included in what Rainbows did, there were 919 screenings provided (up 300 from previous year). Bright Beginnings served 184 children in 2011 (up about 20 from 2010). They served 140 in the last six months. ### **Smart Start & Early Childhood Block Grants – Audra**

We are funded for 2012. We put out the applications for Child Care Scholarships. We are budgeted to serve 23 children with this scholarship; we received 28 applications.
